

# Privacy Policy

This Privacy Policy ("Policy") applies to [www.rezeksolutions.com](http://www.rezeksolutions.com), and Rezek Solutions ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include [www.rezeksolutions.com](http://www.rezeksolutions.com). ## Collection of your Personal Information

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

### **Sharing Information with Third Parties**
